ANNUAL APPROPRIATION ORDINANCE AND ESTIMATE OF REVENUES OF THE CITY OF ATHENS ROAD DISTRICT NO. 13, ILLINOIS, FOR THE CORPORATE YEAR BEGINNING MAY 1, 2024, AND ENDING APRIL 30, 2025.

An ordinance appropriating for all corporate purposes of the City of Athens Road District No. 13, Menard County, Illinois for the fiscal year beginning May 1, 2024, and ending April 30, 2025.

BE IT ORDAINED by the City Council of the City of Athens, Menard County, Illinois:

SECTION 1.
